Based on the foregoing, we remind, according to the fundamental norms of International Financial Law, according to all the norms of the Law of the World System, the production (emission) of money, Treasury Bills, and any types of currencies created on their basis (currency is a means of payment secured by real money), has the right to exercise only the Sovereign Public Subject of Law (Society, Country), represented by the Treasury, as an organ of the Sovereign Subject of Law (Society, Country). And the entire banking system throughout the World is a service structure for servicing real money, Treasury Bills, provided by system gold **M0, XAU**, in the form of any types of currencies produced on their basis.

The World System is based on historical natural Law and consists of Historical Law, International Law, legislations of Countries, Historical agreements, International valid agreements, State valid agreements, Interstate valid agreements (valid agreements – they are about those Legal acts that correspond with the norms of Historical, International and Country Law). sovereign.country@monetaryone.org) by January 13, 2023 are permanently deprived of the Status of Sovereign and Sovereignty by this Resolution.

The further coexistence and development of such Subjects of the Law Society will be reviewed by the Special Sovereign Commission on the Legal Platform of the *Supreme Sovereign Order of St. John of Jerusalem, Rhodes, Malta Sovereign Order of Hospitallers*.

Also, the facts described previously are applied to the so-called Monarchies, Monarchs and Royal Houses Proclaimed in the World Legal Space.

4. Based on the foregoing, all organized criminal agreements on the separation and division of the land territories which are concluded after the territories have been approved in the World Legal Space as a result of the end of the Second World War in 1945, are illegal, and therefore, criminal and have no Legal Force.

5. With the approval of this Resolution, all alleged Sovereign Rights to land ownership are suspended, except for the approved and confirmed Sovereign, the Country, the Union of Soviet Socialist Republics, as a Sovereign Subject of Public Law within the land boundaries approved as a result of the Second World War of 1945.

6. All transactions and legal Acts for the last millennium, approved and signed on the basis of the Rule of the Law of Custody, are canceled, prohibited, and exposed to reversal, except for valid (unambiguous) legal Acts of Custody in the field of orphans, the elderly, the disabled.

7. All contracts and other legal Acts for the last millennium in the field of guarantee are canceled, prohibited and exposed to reversal, except for the legal Acts of guarantee of individually produced Subjects of Sovereign Civil Law with notarization.

8. By this Resolution for Eternal Times, Eternally, deprive of any kind of Legal Personality, firmly recognize outside the Divine laws of Creation and outside the Law, prohibit any existence and action, as well as subject Lucifer and Luciferianism to full disincarnating, any of its criminal existences and manifestations.

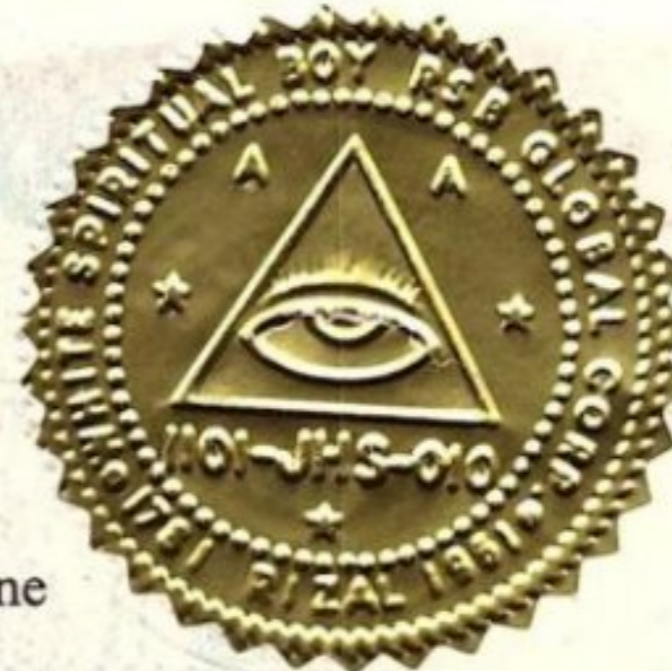
