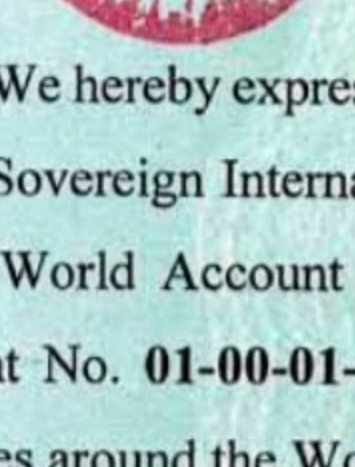

- We hereby affirm and warn that in the event that any Country of the World, any Subject of the Public Law of the World, which allows any currency, including any digital currency, any means of payment, including any digital means of payment without lawful legal security with sacred, systemic banking gold M0 through the new reserve World currency M1 (XAU) in the form of Treasury Bills of the Sovereign International Treasury Monetary One, in accordance with the Order of the Sovereign International Treasury Monetary One No. 001 Anti-Crisis financial measures dated April 07, 2020 and in accordance with the recommendations of the International Basel Committee on Banking Supervision (Basel III Standard), as well as those that do not have official registration and official written permission for legal circulation as a currency or other means of payment from the Main Regulator of the entire World Banking System - the World Sovereign Bank of the Order Hospitallers, then these Countries and any Subject of Public Law will be subject to annexation from the entire World System, as well as from the entire World Financial System until the Country or Countries, or any Subject of Public Law, which has admitted the above-described International and State financial crime equated to International terrorism, until it performs an act of justice to eliminate this criminal activity with the arrest and prosecution and criminal punishment with all the strictness of the law of any Subjects of Law, individuals and organizations that commit and have committed an International and State financial crime, equated to international terrorism, prescribed in this Order.
